## REPORT ON NATIONAL LEVEL WORKSHOP ON “THE LOKPAL & LOKAYUKTAS ACT, 2013”

R. L. Law College, Davangere an IQAC Initiative in association with District Bar Association, Davangere jointly organized **National Level Workshop on “The Lokpal & Lokayuktas Act, 2013”** on 21<sup>st</sup> June 2024. The workshop had been inaugurated by **Hon’ble Justice Sri L. Narayana Swamy, Judicial Member, Lokpal of India and Former Chief Justice of Himachal Pradesh High Court**. As a Chief Guest and Resource person, Hon’ble Justice spoke about working of Lokpal in India, and its powers and responsibilities. Guests of Honour Sri L.H. Narayana Swamy</b></p> <p>Born on 01-07-1959 in Bhadravati, Shimoga District of Karnataka, he completed his LLB from National Law College, Shimoga and LLM from Mysore University. Enrolled as an Advocate during the year 1987 and practiced in the High Court and worked as High Court Govt. Pleader from 1995 to 1999. Appointed as an Additional Judge of the High Court of Karnataka on 04-07-2007 and permanent Judge on 17-04-2009 and the Acting Chief Justice from 17-01-2019 to 09-05-2019. Transferred to Himachal Pradesh High Court as Chief Justice in 2019 and demitted office on 31st June 2021. Appointed as Chairperson, State Human Right Commission, Karnataka on 25th November, 2023 till 11th March, 2024.
