One Day National Seminar on: The Role of Lokpal System in Strengthening Transparency and Accountability in Administration

The college organized one day National Seminar on "The Role of Lokpal System in Strengthening Transparency and Accountability in Administration" on 6th June, 2026. The programme aimed to create awareness among students and the public regarding the importance of the Lokpal institution in ensuring transparency, accountability, and good governance. The inaugurator and the resource person of the programme was Justice L. Narayana Swamy, Former Chief Justice of High Court of Himachala Pradesh and Judicial Member of Lokpal of India, New Delhi.

The keynote address was delivered by Justice L. Narayana Swamy. In his enlightening address, Justice Narayana Swamy explained the significance of the Lokpal System as an independent anti-corruption institution established under the Lokpal and Lokayuktas Act, 2013.

He highlighted the role of the Lokpal in investigating complaints against public servants and emphasized the need for transparency and accountability in public administration. He discussed the powers and functions of the Lokpal, the procedure for filing complaints, and the importance of maintaining ethical standards in governance. He further stressed that effective implementation of anti-corruption laws and active citizen participation are essential for strengthening democratic institutions.

Justice Narayana Swamy also elaborated on the important role of advocates in strengthening the justice delivery system and promoting accountability in administration. He stated that advocates act as guardians of the rule of law by assisting courts and quasi-judicial bodies in the fair administration of justice. He emphasized that advocates have a professional and ethical responsibility to uphold truth, defend constitutional values, protect citizens' rights, and support efforts to combat corruption. He encouraged law students to develop integrity, legal competence, and a strong commitment to public service so that they can contribute to a transparent and accountable governance system.

The session provided valuable insights into the challenges faced in combating corruption and the measures adopted by the Lokpal to ensure fair and transparent administration. Students and faculty members actively participated in the interactive session and clarified their doubts regarding the functioning of the Lokpal system and the legal profession's role in promoting good governance.

The seminar concluded with a vote of thanks, expressing gratitude to Justice L. Narayana Swamy for sharing his knowledge and experience. The programme was highly informative and successful in enhancing awareness about the role of the Lokpal in promoting transparency, accountability, and integrity in administration. Dr. M. Somashekharappa, Director, R.L. Law College and Prof. B.P. Basavanaguda, Principal, present in the program. Dr. R. L. 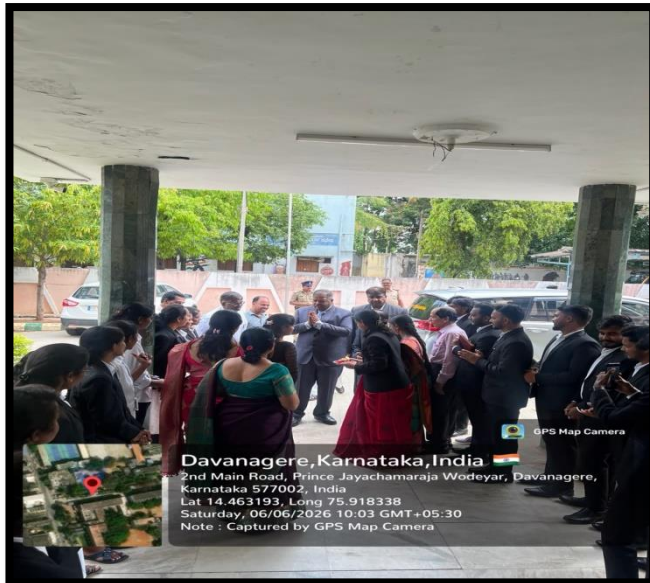
